IMPACT

Lilianna had always been known for her radiant smile and infectious laughter, but over time, those who knew her began to notice the shadows that lingered in her eyes. Along her journey she had met Marcus, the man who would become her husband. As a young single mom seeking to build a safe and happy family life, she was drawn to his charm and confidence; having someone that is a great friend and attentive to her and her son's needs made her feel like the most cherished person in the world. However, as the months turned into years, the cracks in his façade began to show. His jealousy turned into rage, and his love into possession. The bruises on her arms were easy to excuse, the weight of shame silencing her whenever friends or family inquired about her well-being.

The abuse wasn't confined to his fists. Marcus manipulated her with threats and coercion, exploiting her vulnerability in the most intimate ways. Nights became her greatest dread, as she endured the pain and humiliation of his sexual aggression. Lilianna felt trapped, her spirit crushed under the weight of his control. He isolated her from everyone she loved, convincing her that no one else would ever care for her.

One day, a friend of Lilianna's encouraged her to seek counseling to assist her with processing her emotions and fears, with hopes of restoring some self-confidence and courage. Lilianna was reluctant to engage in counseling services due the challenge she felt of trusting others. Despite her fears, Lilianna reached out to Gulf Coast Center for Nonviolence with hopes of starting her journey of self-improvement. When Lilianna first walked into the therapy room, her body seemed to shrink into itself, her eyes avoiding contact as if even glances could hurt. The years of extensive abuse had carved deep wounds into her selfesteem, leaving her feeling invisible and powerless. In her first two sessions, the silence was deafening; words felt like a risk too great to take. She feared judgment, feared that speaking aloud would somehow make her pain more real, or worse, invite criticism, just as Marcus had conditioned her to believe. The therapist's gentle patience and unwavering presence, however, created a small but vital space for trust to grow. Lilianna's fear didn't disappear overnight, but with time, she began to see that her voice mattered, even if it trembled.

She managed to escape while Marcus was at work, removing as much of her and her son's items as she could and embodying a newfound determination to reclaim her life. The road to healing was neither quick nor easy, but with therapy, friends, and support from survivors like her, she began to rediscover her strength. For the first time in years, Lilianna allowed herself to dream of a future free from fear, knowing her survival was the greatest testament to her resilience.

As Lilianna continued therapy, she slowly began to embrace the therapeutic tools and strategies offered to her. Grounding techniques helped her manage the overwhelming fear that often paralyzed her, while affirmations and journaling allowed her to reclaim a sense of self-worth that Marcus had tried to destroy. With her therapist's guidance, she worked on building a safety plan, identifying trusted friends who could offer support and a safe place to stay. Empowered by the growing belief in her own strength, Lilianna reached out to a local advocacy group that helped her navigate the legal system to obtain a protection order against Marcus. Each step, from speaking up in court to leaning on her support network, became a testament to her resilience. For the first time in years, Lilianna felt the possibility of freedom within her reach, armed with the knowledge that she was no longer alone in her fight.

With the consistent support of her counselor and case manager, Lilianna began to see her life take a dramatic turn toward stability. Navigating the complexities of her immigration status, she worked tirelessly to gather the necessary documentation and evidence of her circumstances. Her case manager connected her with legal advocates who specialized in assisting survivors of abuse, guiding her through the process of applying for legal status under protections for victims of violence. The determination that had carried her out of Marcus's grasp now fueled her pursuit of independence, and as she has grown closer to receiving her legal status, it feels like the closing of one chapter and the opening of another filled with hope.

Making profound steps in securing her legal status allows Lilianna to focus on maintaining her employment, a vital step in rebuilding her life. With steady work, she saved diligently, proving to herself that she could stand on her own two feet. She applied for and secured an apartment that became her sanctuary—a space free from fear and filled with promise. Every piece of furniture she brought in, every bill she paid on her own, was a small but significant victory. The journey was far from easy, but Lilianna's hard work and the support she embraced were powerful reminders of her resilience and the brighter future she was creating for herself.

Lilianna often reflected on her journey with immense gratitude for the unwavering support and guidance she received from the staff at the Gulf Coast Center for Nonviolence. Their compassion and expertise became a lifeline during her darkest moments, providing her with the tools and encouragement she needed to rebuild her life. From counseling sessions that helped her heal emotionally, to case management that guided her through legal and financial hurdles, every step of the process was met with kindness and understanding. The staff's dedication went beyond professional assistance—they empowered Lilianna to believe in her own strength and reclaim control of her future. Now, as she enjoys a life filled with peace and newfound purpose, she holds deep appreciation for the Center and the role it played in helping her find safety, stability, and hope once again.




