

ETHO TAX CREDIT DONATION

Through the Eligible Transitional Home Organization (ETHO) Tax Credit Program, you or your business can make donations to our Center and use that gift to offset up to 50% of your Mississippi tax liability!

You're already paying for your taxes, right? Now up to HALF of that payment can be directed to our program as a donation, and it counts just as if you'd paid it to the State. You're able to keep more of your tax dollars local and see the direct impact of your contribution! community.

- ▶ It's a tax-smart investment in your community.
- ▶ Every dollar donated through ETHO reduces your MS state tax liability by the same amount.
- ▶ This credit can be used to offset up to 50% of your Mississippi state income tax liability and can be carried forward for five years!

MAKING YOUR ETHO DONATION

1. PREPARE

Decide your contribution amount, and which tax you'd like to apply your credit to. You can apply ETHO credit to:

- ▶ Income Tax (50% of tax liability)
- ▶ Insurance Premium Tax (50% of tax liability)
- ▶ Insurance Premium Retaliatory Tax (50% of tax liability)
- ▶ Ad Valorem Tax (50% of real property tax liability)

2. APPLY

- ▶ Visit the Mississippi Department of Revenue Taxpayer Access Point (TAP) online portal at tap.dor.ms.gov.
- ▶ Select the "Apply for a Charitable Contribution Credit" link under the "Apply Online" section.
- ▶ Select "ETHO" as the type of charitable contribution credit.
- ▶ Fill out your business taxpayer information.
- ▶ Select Gulf Coast Center for Nonviolence, contribution date and amount.
- ▶ Submit the application; you should receive your confirmation number right away by email.

3. RECEIVE CONFIRMATION

MDOR will send a letter confirming your approved credit allocation, usually within 30 days. You must make your donation within 60 days of the letter date (or by December 31st, whichever comes first) to retain your allocation.

4. DONATE

Submit your donation to GCCFN, either online at gccfn.org or by check payable to Gulf Coast Center for Nonviolence sent to P. O. Box 333, Biloxi, MS 39533. Please write "ETHO" in the memo or notes section. We will send you an official receipt letter on our letterhead showing the donation amount and date.

5. SUBMIT

- ▶ Return to the MDOR TAP Portal at tap.dor.ms.gov.
- ▶ Click "Upload Requested Documentation" under the "Upload Documents" section.
- ▶ Upload the letter we sent you (as a PDF, JPG, or PNG file).
- ▶ Save your upload confirmation number for your records.

6. RECEIVE CONFIRMATION

Within about 30 days of submitting your donation letter, MDOR will send you a final approval letter confirming receipt and the status of your credit. Keep this document for your tax records.

7. CLAIM YOUR CREDIT

Claim the ETHO credit on your Mississippi tax return for the approved year. Non-corporate entities applying for credit toward ad valorem tax will receive a schedule from MDOR to provide to their County Tax Collector. Any unused credit may be carried forward for up to five consecutive years.

MISSISSIPPI'S FIRST FAMILY JUSTICE CENTER





IMPACT

My name is Earlonda, and I describe myself as “easy like Sunday morning.” I am a woman who loves God, people, and family.



After years of marriage, raising children, and welcoming grandchildren, my husband and I eventually grew apart and made the decision to divorce. I took time to heal, reflect, and rebuild my life. When I finally felt ready to open my heart again, I met someone who first became my friend through a dating app. He lived in Mississippi, and I lived in Indiana. We traveled back and forth to see each other, and eventually we got married. It was the day he chose.

Looking back now, I ignored many red flags. He was controlling in very smooth ways. I had never been with someone who had that kind of charm before, and we had many things in common. But soon after the marriage began, problems started. He did not want me to work. One day, after an argument, he asked me to leave the house—even though I had given up my home and left my family to be with him. I went to Adrienne's House and stayed for three days. During that time, I thought deeply about my life and my choices. Eventually, I went back, hoping things would change. But the only thing that truly changed. . .was me.

I was slowly losing myself. I was giving up my dreams. I felt lonely and emotionally stressed. Everything revolved around him. Still, I kept praying, reading my Bible, and trusting God. Later, I discovered that during our entire relationship, he had continued relationships with other women.

I thought he was going to take me to Alabama to see the Christmas lights. Instead, he took me to sign divorce papers. That moment was shocking and painful. The ride home was tense. He became angry and violent because I was asking questions and speaking up for myself. This was only seven months into the marriage. The following day, he told me I had to leave again. So I called the Gulf Coast Center for Nonviolence and was accepted to stay. That decision became one of the best decisions I could have made.

During that time, I focused on my health, my weight, and my goals. I surrounded myself with positive people and continued going to church. Everything began working together for my good. While at the shelter, I spoke with a Case Manager about housing, and things started moving in my favor. While there, I also received my divorce papers. For a moment, I had a pity party; but through counseling and prayer, God helped me regroup and move forward.


Then one special day came. I received the message that I was approved for the Center's housing program. I remember sitting with a Case Manager as she explained the program to me. I felt overwhelmed. I had never experienced anything like this before. I thought to myself, I'm better than this. I wanted to scream. I had given up so much for that marriage, and now I was homeless. I found the right apartment even though there were some concerns at first. I was able to move in and start working on my goals. Then I enrolled in school at the Adult Learning Center in Pascagoula, Mississippi, to get my GED. I also started working with United Way for Jackson County. On June 6, 2025, at the age of 60 years old, I received my diploma.

Eventually, I returned to Indiana; now I am enrolled in college and preparing to study Social Work with a focus on Addiction and Recovery. My goal is to open transitional homes for women, helping them rebuild their lives just like God helped rebuild mine.

I want to thank God first, my family, the Gulf Coast Center for Nonviolence, the Adult Learning Center, SPMDD, Restoration and Revival Center, and United Way for taking me in during one of the most difficult times in my life. Today, I pray for every shelter and every staff member who helps women trying to start over. Because sometimes the place you never thought you would be. . .is the very place where God begins your restoration.

MAKING A DIFFERENCE TOGETHER

Real change takes all of us working together. Thanks to the dedication of our volunteers, the generosity of our donors, the leadership of our Board of Directors, the commitment of our staff, and the collaboration of our community partners, we are making meaningful progress toward a safer community—one where violence is prevented, survivors are supported, and hope continues to grow.




